

RECTOR'S ANNUAL REPORT FOR 2007

Good Morning

It is an exciting honor to come to this Annual Meeting Sunday as the sixth rector of St. Mark's. I am particularly pleased to join the congregation at this moment in our life as a parish, a moment that feels to be filled with a vibrant vitality around what God has done and will do through this congregation.

You and I stand today upon a firm and steady foundation of faith and hard work. Most Recently we owe a tremendous debt of gratitude to a number of people: Our dedicated and wise wardens, Ellen Berndt and Bill Silliman; an energetic and spirit-filled search committee with Phil Glandon and Pat Iams in the lead; a focused and enormously productive Vestry; a caring and fun interim rector, Philip College; a staff with whom it is a privilege to serve; and my predecessor, Dr. Vicki Smith who served with faith and a truly inspired vision for the future. We are blessed by these fine people and many, many others who make up this unique and diverse parish family—and I thank God for each of you.

In my brief time here, you have grown to tolerate my sense of humor, and comment kindly on my love of props and gadgets while preaching. You have also patiently endured a number of changes in the liturgy, from moving the baptismal font, to our new comprehensive service bulletin, to the increased role of vergers and the formation of the St. Mark's Verger's Guild. At each turn, Bruce and I have carefully tried to show the significance of each change and its meaning. It is my hope that when our liturgy finally comes together there will be a collective "ah - yes" and a sense of what the late Urban T. Holmes called: that Anglican environment "where our souls fall in love with God."

This Liturgy will be at the heart of our congregational life, where we come out of the controversies and turmoil of our world to be refreshed and reinvigorated, and out from which we go as the heart and hands and mind of Jesus Christ as nothing less than his beloved disciples. This is a tall order, make no mistake. Yet this is a gifted and truly wonderful congregation. Still, it will take each and every one of us to discern where God may be calling us to go, and to realize the incredible opportunities that lie ahead following where the Holy Spirit may lead.

A few short notes from my few short months in 2007. September saw the call of a new Youth Minister at St. Mark's— Dan Karl—who is doing an outstanding job, and to whom our young people are already turning during some of the most challenging times of their lives. In addition, the year witnessed a most happy miracle, as the number of children in our Church School program continued to grow, and began to approach the maximum capacity of our education wing. Anticipating this, we made plans to move Associate Rector Bruce Smith's office to the Conference Room, and the volunteer desk in the Conference Room to the Oratory. To make it simple: if you want to see someone in a collar - start walking THAT way—and keep on going and going and going! My Installation service in December was a time of great festivities, from the glorious music, the beautiful and elegant reception, to one of the largest loose offerings collected going in support of the Millennium Development Goals. The year ended with what was truly the best Christmas pageant ever and the lifting high of Christ's light during the singing of Silent Night. It's hard to imagine worship getting any better than this.

So what is in store for 2008? What of this bright new year that lies ahead?

It is a great pleasure to welcome to St. Mark's this morning two very dear friends: Bill and Becky Cyrus from St. John's in Huntington, West Virginia. Bill was senior warden of that parish when it welcomed so warmly a newly ordained deacon from Vermont called Paul—fresh out of seminary and more than a little wet behind the ears. So much of what I have learned about vestries and parish dynamics, of ministry outside of seminary "in the real world," I have learned from the wise and kind hearts of Becky and Bill.

I remember a number of occasions at St. John's when we had to make a major purchase for the parish. Sometimes these would involve negotiating the price of a particular item or project. Bill would take us to the manager and firmly ask for a discount on whatever was quoted. The manager usually took off ten percent saying they liked to support non-profits. Bill would then look him right in the eye and say: "Thank you. That's what you're doing for the church. Now, what are you going to do for God?" It was usually worth another ten percent.

My friends, In so many ways that is the question for all of us in 2008. What are we going to do for God? How are we to

grow into our very best selves, ever closer to who God would have us be? How are we to reach out into our hurting world in the name of Christ?

As your Rector, I have three charges for us today:

First, deepen our sense of Christian community. This will be done through worship together. It will be done by deliberate prayer for and by the many groups that make up our parish. We must be a church that prays and cares for each other whenever and however we gather. I call upon the Vestry to help each group at St. Mark's—from Acolytes to Communications to Finance—to be people of prayer.

Deepening our community also involves being more welcoming—a parish that does not shy away from the "radical hospitality" modeled for us by Jesus Christ. We must look for ways to make our campus more "user friendly" for both new people and long term members alike. Everything from signs to exterior lighting should be addressed. I had a reporter call recently from the Columbus Dispatch. She was late for a meeting with me. "I need directions," she said, "I've been up and down Redding and Tremont Roads and I don't see a church." People have to find us. Once they do, we need more Parish Greeters, and the formation of a Welcome Team to help new members enter into this community, and help make St. Mark's "their" parish, not "our parish" as quickly as possible.

Second, In order for us to live into any of the first charge we must get our physical "house" in order. Many of us are aware of the numerous roof problems we have had of late—from the hail damaged skylight to ice dams over the new parish hall. We are addressing these issues and will continue to do so. We are blessed with available funds needed to take the necessary steps. Yet, what some people do not know, and now must be told, is that parts of the old Parish Hall and Educational Wing are in critical crisis. The West and North wall of the building are failing and need immediate attention. The wood is so rotten that you can take a pen and push it through into the building. Our church school classrooms are not just over crowded, they are falling apart. The answer to mold and mildew here is not more cans of Lysol, it's replacing the exterior walls: a project that could cost upwards of \$300,000. I'm afraid funds for this project are simply not available. In order to make the repair that must be made, a capitol campaign is mandatory. In the next few months we will all be learning more about this. Meanwhile, I invite everyone to exit after lunch today by the lower blue door in the Education Wing - and look up at "the wailing wall" as Bruce has dubbed it. Members of the Vestry will be available to answer questions. When the time comes, please be generous in your giving.

Lastly, we must be attentive to our "spiritual house" as well. This is the very reason for having a physical campus in the first place. I would like St. Mark's to look for ways to more fully live into the Millennium Development Goals in a "hands-on" way, with particular emphasis on an humanitarian trip into the Third World in 2008. This could be a trip overseas, or it could be a trip into parts of our own country.

You know, one of the most meaningful ways I have grown spiritually in the last decade has been by travel into the Third World, and actually spending time working side by side residents of La Labor, Guatemala and Sablino, Russia. My friends, I firmly believe that we send our resources into the Third World to help change it, and we send ourselves there to help change US. I hope and trust that through the Holy Spirit this change may be ever more into the likeness of our Lord who promises his transforming power is already among us.

And so... Those are my charges for the New Year. If we think St. Mark's has been a vibrant and busy and growing place in the past we'd be right. You all got this wonderful place started—there's no slowing down now!

The Lord be with you.

MINUTES FROM ST. MARK'S ANNUAL MEETING - FEBRUARY 11, 2007

The 2007 annual meeting was held in the sanctuary following the Sunday 10 AM worship service. The meeting was called to order and opened with a prayer by the Interim Rector, The Rev. Philip College, at 11:15 AM. A booklet containing the Interim Rector's report, committee reports, Parish statistics and items to be discussed at the meeting was available for all who attended as well as for parish members unable to attend the meeting.

Upon motion made and seconded, minutes of the 2006 annual meeting were approved as presented.

Fr. Philip thanked the Wardens, Vestry and Treasurer, Dot Yeager, Bookkeeper, Rick Moore and Clerk, Virgene Heckman for their service. He also announced that the Treasurer, Bookkeeper and Clerk will each serve for another year. Gifts were presented to the retiring members.

There being no further nominations from the floor, the nominations were closed and by MOTION, SECONDED AND PASSED the nominees were elected by acclimation.

FINANCIAL REPORT

Dot Yeager presented the financial report for the year ending December 31, 2006 and the budget for 2007. She began her report by acknowledging and thanking the volunteers who help with the financial records and bookkeeping: Pat Barton, Maggie Hutchinson, Gloria Wylie and Rick Moore Special gifts received during the year reduced the amount needed to be withdrawn from the additional staff fund to balance the 2006 budget. Also transfers were made from the Trinity Guild Fund to cover the cost of some building repairs The budget for 2007 shows income based on pledges in hand and estimated additional income. The Diocesan standard calls for staff increases of 3% each year and because there was no increase in 2006, the budget provides for a 6% increase in 2007 ... The amount pledged is greater than for 2006, but we will still have a deficit estimated at \$ 45,387 for the year which will have to be made up from the Additional Staff Fund ... In addition to this, there is a need for major repairs to the outer east wall of the education building and possibly extensive organ maintenance. These issues will have to be addressed when we have determined what is needed and what the cost will be.

DISCUSSION

Fr. Philip urged all attending to stay for potluck dinner and thanked Andi Waller and the Vestry for arranging it.

There being no further business, the meeting was adjourned with a prayer led by Associate Rector, The Rev. Bruce Smith at 11:30.

Established to provide reserve funds for major capital maintenance and repairs.

Additional Staff Fund:

Established to provide reserve funds to sustain our two-clergy staff.

The St. Mark's Endowment Fund:

Established in 1978 to protect the long-term financial health of St. Mark's and managed by separately elected Trustees. The fund's yearly investment income is transferred to St. Mark's for use in the operating budget as needed. Gifts totaling \$7,576 in memory of Beth Gilbert were received earlier this year and have been recorded as permanently restricted. As of December 31, the Endowment stood at \$228,622.72.

LIVING AS STEWARDS AT ST. MARK'S CHURCH

February 2008

Dear friends in Christ,

For Christians, stewardship is a way of life, or should be. It is what we do with what we have, all the time, to the glory of God. Stewardship is our grateful response to God for the gifts we have been given by God, through the giving of our time, talents and financial resources. And, we are called to be good stewards of all of God's creation including the earth, the seas, the skies and all that has life and breath.

Living the life of a steward involves keeping the promises we made in The Baptismal Covenant. These include faithfulness in worship, resisting the evils of the world which confront us, proclaiming by word and example the love of Christ, seeking and serving Christ in all persons, loving our neighbors as ourselves, striving for justice and peace among all people, and respecting the dignity of every human being.

Our wardens, vestry and treasurer are the elected leaders of our congregations who work together with each other and our clergy to guide the congregation in its mission and ministry to the members of the congregation and to the wider community. They are, for example, entrusted with the management of the funds, pledges, and bequests given to the church. They are entrusted with the care of the church building and property. We, the congregation, have elected them to act on our behalf, making them *stewards* of the trust they have been given.

Our clergy are raised up to their ordained ministry by God's call as well as by the affirmation of the wider community. At their ordinations they make promises before God and the assembled community as to how they will live their lives as deacons or priests. In living out their ordination vows, the clergy are acting as *stewards* of the trust put in them by God, by their bishop, by their congregation, and by their friends and family.

As responsible stewards we are all called, lay members and clergy alike, to give what we can of our time, talents and financial resources to God through the ministry we all share at St. Mark's. Last year we lifted up the stewardship of our time and talents as we asked folks to discern and offer their gifts for ministry. Many of you did just that, and we are grateful.

The funding of the ministry of St. Mark's Church depends on the financial commitment and generosity of our parishioners. That is why we ask all of our parishioners to make financial commitments in the fall for the coming year. That level of commitment has been increasing slowly but steadily over the last few years, and we thank God for that. Elsewhere in this Annual Report are charts that provide some statistics about giving at St. Mark's for 2008 including a look at annual giving over a 7 year period.

We need to point out that our regular financial giving should be guided primarily by our relationship with God, and not just by the financial needs of our local congregation. So, we continue to lift up before the people of St. Mark's practice of proportionate (or percentage) giving, that is, the giving of a predetermined percentage of our income to God through the work of the church. And, we encourage all of the people of St. Mark's to consider the biblical tithe (10%) as their standard of financial giving to God. We recognize that not everyone can do this, but the biblical tithe remains our goal. Just imagine how much we could do, how many we could help, if everyone at St. Mark's began to tithe!

ORGANIST-CHOIRMASTER'S REPORT

New Choristers

Our ongoing New Choristers program prepares boys and girls ages 7 to 12 for entrance into the Canterbury Choir. The children follow the Royal School of Church Music "Voice for Life" curriculum. Sessions are tailored to the individual child's needs, and can begin at any time on an individual basis or in groups of two or three. This past fall, we welcomed four new choristers, three of whom joined the Choir in January 2008.

Canterbury Choir

Canterbury Choir, in its 2007-2008 season, has a total of nine members. As customary for the past sixteen years, we began our fall season with Choir Orientation on Labor Day weekend. The choir puts on two annual fund-raising projects, the proceeds of which help meet the costs of year-end educational trips and, every three years, trips to Washington National Cathedral. As our autumn fund-raiser, the boys and girls make and sell buckeyes, and every January "Super Bowl Subs." Two potluck dinners, fall and spring, offered fellowship with choir parents and the choirmaster.

St. Mark's Choir

St. Mark's Choir currently has thirty-two members. In 2007, the choir presented two choral evensongs and Advent Lessons and Carols. As always, these services were open to the community and again this year attendance surpassed the previous year's. The choir provided music for our Maundy Thursday and Good Friday liturgies and for the Great Vigil of Easter. The Choir accepted an invitation from the American Guild of Organists to sing choral evensong in June 2007, here at St. Mark's, for the Midwest regional convention. Three hundred organists, choirmasters, and clergy attended, from twenty-two states.

Music Series Launched

Our St. Mark's Music Series was launched this year past year. It presented Erik Wm. Suter, the organist of Washington National Cathedral, in recital, Opus String Quartet, the chamber chorus Fior Angelico, and Columbus Children's Choir. This annual series is envisioned as encompassing our regular choral evensongs and including an annual organ recital by a major artist. It will also encourage young musicians who are just starting out on their careers.

Members of the choirs, the choir parents, the choir mothers, and the members of St. Mark's Choir give generously of their time and work for extra rehearsals on Saturday mornings and on other occasions, and for special activities of many kinds, and they arrive an hour ahead of time for every liturgy they sing. Each member of the St. Mark's Choir volunteers more than 400 hours of service to the parish every season. To each and every individual who contributes time, energy, talent, and dedication to St. Mark's music program, my heartfelt appreciation.



ADVLT EDUCATION COMMITTEE REPORT

Dear friends in Christ,

This past year saw a shift in programming for adult education programs at St. Mark's. We began the year with pretty much the same type of scheduling that we have used for several years, but made some changes in the latter half of the vear.

Six different Tuesday evening courses were offered between January and July, including the popular Lawn Chair Theologians program held in July. Sunday Morning forums met regularly throughout the year and covered a variety of topics. We also offered a Lenten Quiet Day and an Advent Quiet Day (particularly well attended!)

We have noticed over the past few years that attendance at evening programs, with the exception of the Kerygma Bible Studies has been declining. Winter weather is one factor. Driving at night is also a concern for some folks. We also noticed that the Sunday morning Forums were appealing to a regular but small group. In Advent we offered "The Gospels of Advent" and saw attendance at the Sunday Morning Forums double, so we continued offering Bible studies for Epiphany and Lent 2008.

What did we learn from all this? There is a hunger of Bible Study at St. Mark's, and that need is being met by the ongoing Wednesday Morning Bible Study, but also by the Sunday Morning Forums and by the recently

formed Men's Group which currently meets monthly on the 3rd Wednesday of each month at 5:30pm.

Going forward in 2008, we will continue our focus at the Sunday Morning Forums on Bible Study but may provide other offerings from time to time. We will continue to offer Tuesday evening seminars from time to time, but not as frequently as in past years. We are also considering a film series for sometime in 2008.

The Adult Education Committee consists of Bob Graves, Stan Laughlin, Matt DeMatteo, and Gloria Wylie. While our face to face meetings are infrequent, we stay connected through modern technology – e-mail.

FORMATION REPORT

Elementary Education (ages 3 through 5th grade) - submitted by Amy Keller

Sunday School continues to grow and thrive as we welcome many new families to St. Mark's. Sunday School enrollment is currently 48 children (25 families). Our attendance has continued to climb steadily with our average for the 2007/2008 school year at 22 children per Sunday. The 05/06 average was 12; 06/07 average was 14; and 07/08 average was 18. For this school year, our highest attendance was 32 (last years high was 26), and our lowest number was 11 (holiday weekend). Sunday School teachers and volunteers have worked very hard to put together engaging lessons using the Godly Play curriculum for the Preschool children, and a special study of the 10 Commandments, using the Kid's Travel Guide to the 10 Commandments, for the K-2nd grade classroom and the 3rd-5th grade classroom. We continue to add new stories and appropriate curriculum for our older children as we move to a new 3-year cycle of lessons and stories.

Because our enrollment continues to grow, we will continue to split the children into 3 classrooms, which requires a larger number of parent volunteers each week. Sunday School is in session for 28 Sundays (1 orientation) from September through May. Teachers this year are: Elizabeth Anstaett, Martha Belury, Anne Botti, John and Valerie Goettler, Amy Keller, Park Zimpher. Katie and David Renner, and Kathy Drobny. Our fantastic assistants are: Ted Keller, Jennifer Rubin-Koenig, Elizabeth McLaughlin, and Mara and Greg Smith. We are all looking forward to the upcoming repair and renovation of the Education Building, which will provide a much-needed increase in clean, safe, useable space for our children.

Sunday School Outreach - submitted by Amy Keller

We have continued the tradition of taking a collection in Sunday School for Heifer International. The mission of Heifer International aligns perfectly with the Episcopal Church's Millennium Development Goals. The children continue to be excited about helping to provide food, resources, income, and hope through environmentally appropriate livestock and plant/garden materials to people around the world. Last year the children donated \$300 dollars, which was matched by the Outreach Committee. We donated \$600 toward the purchase of a water buffalo, pigs, llamas, rabbits, goats, chickens, honeybees, trees, and vegetable gardens. In 2007, we also collected food items for Mid-Ohio Food Bank Kid Packs. These child-friendly bags contain snacks, food to share with the family, and a toy or game to needy children over the summer. St. Mark's children also participated in collecting school supplies in the fall and hats/mittens for the hat/mitten tree at Christmas.

Vacation Bible School - submitted by Amy Keller

Kathy Drobny did an amazing job as coordinator of another amazing week of Vacation Bible School (VBS) for children ages 3 through 5th grade. This year's theme was Avalanche Ranch. 30 children participated (up from 21 the previous year). Adult and teen volunteers worked hard throughout the week during this high-energy, highly entertaining, and spiritually rich experience. We were fortunate to be able to offer VBS free to several children from St. Cyprians in Columbus. VBS is open to all St. Mark's children, their friends, family, and neighbors. We expect enrollment to continue to increase this year. Planning is already underway for Power Lab VBS this June 18th through June 22nd. Mark your calendars now.

Christmas Pageant - submitted by Amy Keller

Valerie and John Goettler organized and directed this year's Annual Christmas Pageant. Over 20 children participated in the Pageant along with the Canterbury Choir, 2 Youth Readers, several parents, and one grandparent. This beautiful tradition, paired with a candlelight Communion, was enjoyed by a very full house.

Kids at Nine and Nursery - submitted by Barbara Hyre

Roberta Morton continues to volunteer with the Kids at Nine program. She typically has 1 or 2 children at the 9:00am hour. Laura Karl graduated from high school and resigned her position as our paid nursery worker at the 10:00am service. Diedre Kelleher subsequently accepted the paid nursery worker position. We have about 9 volunteers working in the nursery; one St. Mark's mom and the rest are St. Mark's teens. The majority of teens serving in the nursery opt for "service hours" (required by many of the suburban school districts) rather than pay. Attendance in the nursery has been down this year, mostly because the previous nursery kids are now old enough to attend Sunday School.

Youth Ministry - submitted by Paul St. Germain

Youth Minister Erin Richards resigned during the interim period in 2007. With the excellent help of Barbara Hyre, meetings continued and the search for a new youth minister was begun. In September Daniel Karl was called and he began meeting with the St. Mark's/Trinity Youth immediately. A highlight of the year was to adopt a family through Good Will Industries, and to provide them with clothing, school supplies, and holiday items during November and December. St. Mark's fully funds the youth program on behalf of Trinity and St. Mark's.

FACILITIES GROVP REPORT

2007 followed the tradition of years past in being a busy one for the facilities group, as we continued to work on old issues, along with a few new ones. What follows is a summary of the more notable developments:

Work continued on the skylight over the chancel. In October 2006 a hailstorm cracked several glass panels in the skylight and, in order to prevent further damage, it was covered with a tarp that remained in place through 2007. The process of replacing the skylight turned out to be more challenging than originally expected due to its custom build and the difficulty in locating a company to adequately replace it. After a prolonged search, the insurance company found a company to handle the replacement. Architectural reviews and city reviews followed, and the skylight has been ordered. Because of its custom nature, it is built to the exact specifications of the opening and should be installed in the spring of 2008.

The vestry contracted with the architectural firm of Behal, Sampson & Dietz of Columbus to create a design for the western wall of the education building, including a portion of the southern wall, that has deteriorated and rotted over the past years due to water damage and exposure to the elements. We sought a design that was in keeping with the current one, but with lower maintenance and less opportunity for rot. After going back and forth with the architect, a committee determined that a "storefront system", similar to the front of Johnston Hall with its aluminum panels, is the best solution. Unfortunately, this involves major construction work that would impact the entire building and needs to be delayed until the spring when the weather is better.

Similarly to the crumbling façade of the western wall, the wall that runs along the handicap ramp from the parish hall to the office building is deteriorating. The architect proposed some solutions for its repair, or suggested it could be removed and replaced with a wrought-iron railing – the solution most attractive to the committee. We expect this to take place simultaneously with the repairs on the education building.

Water continues to be a frustrating factor for many parishioners at St. Mark's, your vestry included. Frozen drainage pipes over the winter led to a flooding of Johnston Hall in February and flooding in the Narthex during Lent. The problem is two-fold: frozen and clogged subterranean drain pipes led to a backup of rainwater in Johnston Hall; and poor roof grading and patching led to leaks around the drainpipe in the Narthex. In the late fall, Roto Rooter cleared out the drainage pipes and, with that, brought out a considerable amount of construction debris. We are fairly certain that, as long as the drains are kept unblocked at the curb end, the leaks and flooding in Johnston Hall will be eliminated. Repair of the flat roof over the Narthex will take place around the same time as the education building and wall along the handicap ramp.

Visitors to St. Mark's have felt more welcome with the addition of directional signs throughout the complex. The second test has been very successful and we will be bidding out the project in the first half of the year.

The expected costs of the repairs to the education building, ramp wall and roof are considerable. Thanks to kind donations from anonymous parishioners, the Trinity Guild Fund had a year-end balance of approximately \$65,500. The repair project, however, is anticipated to cost several times that. Sources of funding are being investigated.

Before concluding, the facilities group would like to thank all of the parishioners – those known and unknown – who have helped keep St. Mark's up and running over the last year. From the volunteers at the work days to those who simply turn out lights in empty rooms or ensure doors are properly shut and locked, we wouldn't be able to do it without you.

OUTREACH COMMITTEE REPORT

The Outreach Committee had a productive year, and it is our hope that the membership of the committee will continue to build upon this framework in the upcoming year.

The committee was organized in the spring of 2007, and with input from Interim Rector, Phillip College, established a goal of more closely aligning the Outreach Committee to reflect the work and interest of members of the parish. As such, members of several small group ministries were asked to serve on the Outreach Committee, and bring information to the committee as well as take information back to their respective small group. For example, Clyde Tipton has served on the board of Episcopal Retirement Homes for many years, and as such, Clyde was asked to serve on the Outreach Committee.

I. Outreach Committee Goals, Budget and Objectives

The budget for this year was \$16,000.

The desire of the committee was to establish a more effective framework for considering the various options for Outreach funding. The end result was a decision to establish Tier One organizations, Tier Two organizations and Tier Three organizations, as follows:

Tier One organizations would be organizations that have a long history with St. Mark's; and/or St. Mark's parish members are involved with the organization; and/or we hope to continue on-going support on an annual basis. The Outreach Committee will endeavor to promote these organizations and their important work in an effort to seek additional volunteer support, additional financial support by our parish members, and to encourage more robust parish involvement.

Tier Two organizations would be organizations that have been supported by St. Mark's Church through volunteer support and/or parish collection activity. The Outreach Committee will endeavor to promote these organizations and their work in an effort to encourage more robust parish involvement.

Tier Three organizations would be organizations that request one-time gifts; and/ or non-profit organizations that have requested funding from the Outreach Committee; and/or non-profit organizations with parish involvement and interest but not viewed as a tier one or tier two organizations.

II. The Outreach Committee approved funding for the following TIER ONE organizations in 2007:

- **Episcopal Community Services Foundation**: ECSF is a diocesan-wide organization that funds small grants to churches throughout the Diocese. The committee granted \$1,500 to support ECSF.
- **Episcopal Retirement Homes**: St. Mark's has enjoyed a long and close relationship with ERH over the years. The committee funded the amount of \$3,500 to support the endowment fund for Canterbury Court.
- Episcopal Relief and Development: The committee approved funding of \$2,000 to fund the work of ERD.
- St. John's Town Street: Members of the committee discussed our interest in funding our on-going work and relationship with St. John's. The committee approved funding in the amount of \$1,000.
- **Habitat for Humanity**: Chip Botti has reestablished St. Mark's relationship with the Northwest Partnership. The committee approved funding of \$3,000 in support of Habitat for Humanity.
- Heifer Project International: The committee made two grants to Heifer: one grant was a \$300 match in support of the donations made by St. Mark's Sunday School Group; and the committee also approved a grant of \$1,000 in support of the work of Heifer.

III. TIER TWO organizations/collections

The Outreach committee and our church are lucky to have Rick Moore and Joy Sargent as active members. These two, along with many others, have continued to promote and coordinate our on-going parish wide collection efforts. Rick Moore continued to coordinate the monthly collections and deliver them to NNEMAP.

In addition, Committee members agreed to work on establishing a collection schedule. While work continues on the schedule, the following collections were completed:

- AUGUST: A great response for **Tools for Schools** and school supplies
- SEPTEMBER: Children's Hunger Alliance in conjunction with World Food Day on October 14th and a loose change offering
- OCTOBER/NOVEMBER: Operation Christmas Child shoeboxes had another great response
- DECEMBER: Hat and Mitten Tree

IV. Outreach Funding for TIER THREE organizations

The committee approved funding for the following organizations:

- \$1,500 in support of the Mid-Ohio Food Bank
- \$1,000 in support of Urban Concern
- \$450 for gift cards to give to new mothers in the High Risk Perinatal Project at OSU Medical Center
- \$250 to the Interfaith Center for Peace.
